Appendix 1: Methods

This project was a rapid one, focused on practical opportunities to strengthen the connections between the two sectors. Our methods reflected this, consisting primarily of an engagement exercise with staff from both public health and housing, supplemented by a scoping review of the relevant peer-review and grey literature. More details on each of these strands are provided below.

1.1 Engagement exercise

The engagement exercise consisted of:

- four meetings with the project advisory group, plus a workshop on the potential health impacts of new homes;
- meetings or telephone conversations with a number of key informants identified by the project group, as listed below:
 - Lesley Baird Chief Executive, Tenant Participation Advisory Service Scotland;
 - Ken Gibb Professor of Housing Economics, University of Glasgow;
 - **Gill Leng** National Adviser on Health & Homes, Public Health England;
 - Fiona Moss Head of Health Improvement & Inequality, Glasgow City HSCP;
 - Hilary Thomson Senior Investigator Scientist, MRC/CSO Social and Public Health Sciences Unit, University of Glasgow;
 - Elaine Torrance President, Social Work Scotland; and
 - **Gillian Young** Newhaven Housing Research;
- email engagement with colleagues from public health via the Scottish Directors of Public Health and the Scottish Health Promotion Managers' group, framed around the following three key questions:
 - what are the existing relationships between housing and health in your area?
 - what are the opportunities and barriers to better joint working between public health and housing? and
 - what are your team's needs in terms of developing knowledge and understanding of the housing sector? And finally,
- an invitation to project advisory group members and their networks, and the two aforementioned public health networks, to submit case studies that exemplified best practice in joint working between public health and housing.

1.2 Literature review

Searches of the peer-reviewed and grey literature were undertaken by a specialist librarian in consultation with the project team, using the criteria detailed below. The

databases were selected to provide as broad a range of coverage of potentially useful material as possible, appropriate to our time and resource limits.

Both sets of results were reviewed to identify key papers under the following themes:

- evidence for the relationship between housing and health, and for the potential health impacts of housing interventions;¹
- potential sources of data on housing and/or health in the Scottish context; and
- existing tools and resources that might be used to support joint working.
